

## NOTICE TO CONTRACTORS

Sealed Bids for:

### **OXFORD ROAD AND KELLOGG ROAD STORMWATER DETENTION PROJECT**

will be received for furnishing all materials, qualified labor, tools, and equipment to construct approximately 350 linear feet of new storm sewer pipeline, install stormwater structures, including one box culvert, make earthwork improvements of approximately 250 linear feet of roadside ditch along an Oneida County highway, provide maintenance and protection of traffic, and construct two large detention ponds on approximately 3 acres of land in the Town of New Hartford, NY. This is a high visibility project, and early completion before December 31, 2009 is required.
